**ORDINANCE NO. 2021- 2187**

**AN ORDINANCE ADOPTING THE REPUBLIC ACT 10868 “AN ACT HONORING  
AND GRANTING ADDITIONAL BENEFITS AND PRIVILEGES TO FILIPINO  
CENTENARIANS, AND FOR OTHER PURPOSES” ALSO KNOWN AS THE  
“CENTENARIAN ACT OF 2016”**

**WHEREAS**, the Office of the President issued Republic Act 10868 dated June 23, 2021 entitled, “An Act Honoring and Granting Additional Benefits and Privileges to Filipino Centenarians, and for Other Purposes;

**WHEREAS**, All Filipinos who reach the age of one hundred (100) years old, whether residing in the Philippines or abroad, shall be honored with: a) A letter of Felicitation from the President of the Philippines congratulating the celebrant for his or her longevity; and b) A Centenarian Gift in the amount of One Hundred Thousand Pesos (P 100,000.00);

**WHEREAS**, the Department of Social Welfare and Development (DSWD) issued Memorandum Circular No. 04 Series of 2017 dated February 15, 2017 on the subject Guidelines if the Implementation of RA 10868;


