**ORDINANCE AMENDING ORDINANCE NO. 2021-2114 DATED FEBRUARY 22, 2021, "ORDINANCE AMENDING ORDINANCE NO. 2019-1919 ENTITLED "AN ORDINANCE ESTABLISHING A PROPER SEWAGE TREATMENT AND SEPTAGE MANAGEMENT SYSTEM IN THE MUNICIPALITY OF LOS BAÑOS, LAGUNA AND PRESCRIBING PENALTIES FOR VIOLATIONS THEREOF."**

**WHEREAS**, on February 22, 2021, the Sangguniang Bayan enacted Ordinance No. 2021-2114 entitled " Ordinance Amending Ordinance No. 2019-1919 entitled " An Ordinance Establishing a Proper Sewage Treatment and Septage Management System in the Municipality of Los Baños, Laguna and prescribing Penalties for violations thereof." It was forwarded to the Sangguniang Panlalawigan on April 27, 2021;

**WHEREAS**, on June 14, 2021, the Sangguniang Panlalawigan issued Resolution No. 619, S. 2021, returning without approval Municipal Ordinance No. 2021-2114;

**WHEREAS**, to comply with the recommendations of the Sangguniang Panlalawigan, the Sangguniang Bayan omits prohibited act similar to Section 27 of the prohibited acts of RA 9275 also known as Clean Water Act of 2004. Also, corrections on penalty clause were made thereby omitting the imposition of Community service;

NOW THEREFORE, on motion of Councilor Marlo PJ A. Alipon duly seconded by Councilor Janos S. Lapiz and approved by the councilors present;

BE IT ORDAINED BY THE SANGGUNIANG BAYAN OF LOS BAÑOS, LAGUNA, IN SESSION ASSEMBLED, THAT:

SECTION 1. TITLE. - This Ordinance shall be known as ORDINANCE AMENDING ORDINANCE NO. 2021-2114 DATED FEBRUARY 22, 2021, "ORDINANCE AMENDING ORDINANCE NO. 2019-1919 ENTITLED "AN ORDINANCE ESTABLISHING A PROPER SEWAGE TREATMENT AND SEPTAGE MANAGEMENT SYSTEM IN THE MUNICIPALITY OF LOS BAÑOS, LAGUNA AND PRESCRIBING PENALTIES FOR VIOLATIONS THEREOF."

SECTION 2. AMENDMENTS. This Ordinance amends Section 15 of Ordinance No. 2021-2114.

Additional Provision:

All Acts that are already punished by law (RA 9275 and all other existing laws, shall not be covered by the penal provision of this ordinance.

SECTION 15. PENALTIES - Any owner or user of residential, commercial, industrial, governmental, and institutional structures that fail to comply with the provisions of this Ordinance shall incur the following fines and penalties for every violation:

a. For Residential Homeowners

- I. First Offense Fine of P1, 500.00 and the Issuance of a Notice of Violation
II. Second Offense Fine of P2, 500.00 and Mandatory Environment Related Community Service
III. Third Offense Fine of P2, 500.00 and Non-Issuance of Barangay Clearance;

Succeeding Offenses Fine of P2, 500.00, Environment related Community Service, and continued refusal to issue Barangay Clearance until the owner and/or user complies with the provisions of this Ordinance.

Shall now read as:

a. For Residential Homeowners

- I. First Offense Fine of P1, 500.00 and the Issuance of a Notice of Violation
II. Second Offense Fine of P2, 500.00

**III. Third Offense Fine of P2, 500.00 and Non-Issuance of Barangay Clearance.**

**Succeeding Offenses Fine of P2, 500.00, and continued refusal to issue Barangay Clearance until the owner and / or user complies with the provisions of this Ordinance.**


**SECTION 3. SEPARABILITY CLAUSE** - In the event that any part or provision of this Ordinance is held unconstitutional or invalid, other parts or provisions not otherwise affected shall remain in full force and effect.

**SECTION 4. REPEALING CLAUSE** - All other ordinances, or provisions thereof, inconsistent herewith are hereby repealed.

**SECTION 5. EFFECTIVITY** - This Ordinance shall take effect after fifteen (15) days upon approval.
