ORDINANCE APPROVING THE SUPPLEMENTAL BUDGET NO. 1 OF BARANGAY BAGONG SILANG, LOS BAÑOS, LAGUNA IN THE AMOUNT OF ONE MILLION TWO HUNDRED NINETY TWO THOUSAND SEVEN HUNDRED THIRTY SEVEN PESOS AND 23/100 ONLY (P 1,292,737.23) FOR FISCAL YEAR 2021.

BE IT ORDAINED BY THE SANGGUNIANG BAYAN OF LOS BAÑOS, LAGUNA, in session assembled, THAT:

SECTION 1. TITLE – Ordinance approving the Supplemental Budget No. 1 of Barangay Bagong Silang, Los Baños, Laguna in the amount of One Million Two Hundred Ninety Two Thousand Seven Hundred Thirty Seven Pesos and 23/100 Only (P 1,292,737.23) for Fiscal Year 2021;

SECTION 2. COVERAGE – The amount of One Million Two Hundred Ninety Two Thousand Seven Hundred Thirty Seven Pesos and 23/100 Only (P 1,292,737.23) of Barangay Bagong Silang, Los Baños, Laguna shall cover the expenses for 20 % Barangay Development Fund - Environmental Management : Soil Protection at Kabulusan Creek, Purok 1 - P 1,292,737.23;


SECTION 3. SOURCE OF FUNDS – The amount of One Million Two Hundred Ninety Two Thousand Seven Hundred Thirty Seven Pesos and 23/100 Only (P 1,292,737.23) of Barangay Bagong Silang, Los Baños, Laguna shall be sourced from Beginning Balance (20% BDF prior year 2016 to 2020);

SECTION 4. CERTIFICATION OF BUDGETARY ALLOCATION – The statement of fund actually available has been certified correct by the Barangay Treasurer based on year 2019 and the Municipal Accountant in accordance with the provision of Section 474 (b-4) of R. A. 7160;

SECTION 5. EFFECTIVITY – This ordinance shall take force and effect upon approval subject to all existing auditing rules and regulations.
