ORDINANCE APPROVING THE SANGGUNIANG KABATAAN SUPPLEMENTAL BUDGET NO. 1 OF BARANGAY MAAHAS, LOS BAÑOS, LAGUNA IN THE AMOUNT OF FOUR HUNDRED TWENTY-EIGHT THOUSAND FIVE HUNDRED PESOS AND 0/100 ONLY (P 428,500.00) FOR FISCAL YEAR 2021.

BE IT ORDAINED BY THE SANGGUNIANG BAYAN OF LOS BAÑOS, LAGUNA, in session assembled, THAT:

SECTION 1. TITLE – Ordinance approving the Sangguniang Kabataan Supplemental Budget No. 1 of Barangay Maahas, Los Baños, Laguna in the amount of Four Hundred Twenty-Eight Thousand Five Hundred Pesos Only (P 428,500.00) for Fiscal Year 2021;

SECTION 2. COVERAGE – The amount of Four Hundred Twenty Eight Thousand Five Hundred Pesos and 0/100 Only (P 428,500.00) of Sangguniang Kabataan of Barangay Maahas, Los Baños, Laguna shall cover the expenses for SK Youth Development and Empowerment Programs:

Education and Governance : Rehabilitation of an Alternative Learning School (ALS) Center and Sangguniang Kabataan Multi-Purpose Hall;


SECTION 3. SOURCE OF FUNDS – The amount of Four Hundred Twenty Eight Thousand Five Hundred Pesos and 0/100 Only (P 428,500.00) of Barangay Maahas, Los Baños, Laguna shall be sourced from the Realignment / Reversion of the following projects: a.) General Administration Program: Office Supplies Expenses - P 5,000.00; Other Supplies and Materials (Semi-Expendables) - P5,000.00; IT Equipments - P 70,000.00; b.) Anti-Illegal Drug Abuse Campaign - P 20,000.00; c.) Distribution of Hygiene and Sanitary Kits - P 5,000.00; d.) Distribution of School Supplies - P50,000.00; e.) Module Distribution Assistance for Math, English and Science Literacy - P 50,000.00; f.) Academic Excellence Incentive Program - P 12,500.00; g.) Vegie Gardening Para sa Kabataan - P 20,000.00; h.) Youth Week celebration - P 15,000.00; i.) Youth Camp, Team Building and Trainings - P 20,000.00; j.) SK Mandatory and Continuing Training - P 40,000.00; k.) Youth Assembly (KK) - P 16,000.00; l.) Rehabilitation of Multi-Purpose Covered Court - P 100,000.00;

SECTION 4. CERTIFICATION OF BUDGETARY ALLOCATION – The statement of fund actually available has been certified correct by the Barangay Treasurer based on year 2019 and the Municipal Accountant in accordance with the provision of Section 474 (b-4) of R. A. 7160;


SECTION 5. EFFECTIVITY – This ordinance shall take force and effect upon approval subject to all existing auditing rules and regulations.
