

- SECTION 2. COVERAGE** – The amount of One Hundred Ten Thousand Pesos and 00/100 Only (P 110,000.00) of Barangay Tadalac, Los Baños, Laguna shall cover the expenses for **20% BDF** : Procurement of Food and Non-Food Items for affected by Covid-19 ;
- SECTION 3. SOURCE OF FUNDS** – The amount of One Hundred Ten Thousand Pesos and 00/100 Only (P 110,000.00) of Barangay Tadalac, Los Baños, Laguna shall be sourced from Realignment / Reversion - 20% BDF 2021 : Construction of Multi-Purpose Hall P4 - P 110,000.00;
- SECTION 4. CERTIFICATION OF BUDGETARY ALLOCATION** – The statement of fund actually available has been certified correct by the Barangay Treasurer based on year 2019 and the Municipal Accountant in accordance with the provision of Section 474 (b-4) of R. A. 7160;
