ORDINANCE NO. 2021 - 2226

ORDINANCE APPROVING THE SUPPLEMENTAL BUDGET NO. 3 OF BARANGAY ANOS, LOS BAÑOS, LAGUNA IN THE AMOUNT OF TWO HUNDRED FOURTEEN THOUSAND FOUR HUNDRED FORTY-ONE PESOS AND 00/100 ONLY (P 214,441.00) FOR FISCAL YEAR 2021.

BE IT ORDAINED BY THE SANGGUNIANG BAYAN OF LOS BAÑOS, LAGUNA, in session assembled, THAT:

SECTION 1. TITLE – Ordinance approving the Supplemental Budget No. 3 of Barangay Anos, Los Baños, Laguna in the amount of Two Hundred Fourteen Thousand Four Hundred Forty One Pesos and 00/100 (P 214,441.00) for Fiscal Year 2021.

SECTION 2. COVERAGE – The amount of Two Hundred Fourteen Thousand Four Hundred Forty-One Pesos and 00/100 (P 214,441.00) of Barangay Anos, Los Baños, Laguna shall cover the expenses for **PERSONAL SERVICES**: Service Recognition Incentive - P 100,000.00; Hazard Pay - P 114,441.00;


SECTION 3. SOURCE OF FUNDS – The amount of Two Hundred Fourteen Thousand Four Hundred Forty-One Pesos and 00/100 (P 214,441.00) of Barangay Anos, Los Baños, Laguna shall be sourced from PS Savings Realignment: Honoraria of Sangguniang Barangay – P 158,000.00; Mid-Year Bonus – P 24,021.00; Productivity Enhancement Incentive – P 5,000.00; Monetization – P 6,000.00; Allowance of Brgy. Patrol Drivers – P 16,420.00; Cash Gift – P 5,000.00;

SECTION 4. CERTIFICATION OF BUDGETARY ALLOCATION – The statement of fund actually available has been certified correct by the Barangay Treasurer based on year 2019 and the Municipal Accountant in accordance with the provision of Section 474 (b-4) of R. A. 7160;


SECTION 5. EFFECTIVITY – This ordinance shall take force and effect upon approval subject to all existing auditing rules and regulations.


