

SOURCE OF FUNDS – The amount of Forty-Nine Thousand Five Hundred Pesos and 00/100 Only (P 49,500.00) of Barangay Bagong Silang, Los Baños, Laguna shall be sourced from Beginning Balance (2021) Add: Income Sources: (Funds Actually Available Certified by Local Treasurer or New Revenue Sources or item/s to be realigned in times of Public Calamity – P 30,000.00; Realignment : Medical Assistance – P 10,000.00 ; Honoraria – P 2,764.00; Midyear Bonus – P 2,760.00; Monetization – P 3,964.00; Utility Worker – P 12.00;
