**BE IT ORDAINED BY THE SANGGUNIANG BAYAN OF LOS BAÑOS, LAGUNA, in session assembled, THAT:**

**SECTION 1. TITLE – Ordinance approving the Supplemental Budget No. 4 of Barangay Tadalac, Los Baños, Laguna in the amount of Three Hundred Ninety One Thousand Two Hundred Seventy Four Pesos and 31/100 (P391,274.31) for Fiscal Year 2021.**



**SECTION 2. COVERAGE** – The amount of Three Hundred Ninety One Thousand Two Hundred Seventy Four Pesos and 31/100 (P391,274.31) of Barangay Tadalac, Los Baños, Laguna shall cover the expenses for **PERSONAL SERVICES:** Service Recognition Incentive (SRI) – P 102,000.00; MOOE : Gasoline Expenses - P 289,274.31;


**SECTION 3. SOURCE OF FUNDS** – The amount of Three Hundred Ninety One Thousand Two Hundred Seventy Four Pesos and 31/100 (P391,274.31) of Barangay Tadalac, Los Baños, Laguna shall be sourced from Actual Income in excess estimated income (Real Property Tax) Add : Income Sources: (Funds Actually Available Certified by Local Treasurer or New Revenue Sources or Item/s to be realigned in times of Public Calamity) - P 336,274.31; Realignment amounting to P 55,000.00 (Year End Bonus- P 7,000.00; Cash Gift - P 4,000.00; PEI - P 4,000.00; Medical Assistance- P25,000.00; Monetization - P 10,000.00; Terminal Leave - P 5,000.00)

**SECTION 4. CERTIFICATION OF BUDGETARY ALLOCATION** – The statement of fund actually available has been certified correct by the Barangay Treasurer based on year 2019 and the Municipal Accountant in accordance with the provision of Section 474 (b-4) of R. A. 7160;


**SECTION 5. EFFECTIVITY** – This ordinance shall take force and effect upon approval subject to all existing auditing rules and regulations.


