ORDINANCE NO. 2021-2239

ORDINANCE ENACTING THE SUPPLEMENTAL BUDGET FOR THE GRANT OF GRATUITY PAY TO CONTRACT OF SERVICE AND JOB ORDER EMPLOYEES OF THE MUNICIPAL GOVERNMENT OF LOS BAÑOS IN THE AMOUNT OF THREE MILLION PESOS AND 00/100 (P 3,000,000.00) TO BE TAKEN FROM THE SAVINGS OF THE LONGEVITY GRANT FOR SENIOR CITIZENS AS PER MUNICIPAL ORDINANCE NO. 2021-2117.

WHEREAS, the Office of the President issued Administrative Order No. 38 dated December 29, 2021 entitled: "Authorizing the Grant of Gratuity Pay to Contract of Service and Job Order Workers in Government for Fiscal Year 2021";

WHEREAS, granting a year-end Gratuity Pay to COS and JO workers is a well-deserved recognition of their hard work in implementing programs, projects and activities, including those which are part of the emergency COVID-19 response efforts of the government;

WHEREAS, Section 5 of the Order provides that Local Government Units (LGUs) are enjoined to adopt in their respective offices the grant of Gratuity Pay to COS and JO workers, utilizing appropriate and available funding sources from their respective local government funds. The corresponding supplemental budget for the purpose shall be enacted by the local *Sanggunian* within FY 2021;

WHEREAS, the Sangguniang Bayan after thorough discussion unanimously assented to adopt *in toto* the provisions of Administrative Order No. 46 dated December 29, 2021 entitled: "Authorizing the Grant of Gratuity Pay to Contract of Service and Job Order Workers in Government for Fiscal Year 2021" through the passage of Resolution No. 2021-262;

NOW, THEREFORE, on motion of Councilor Geronimo A. Ciceron duly seconded by Councilor Janos S. Lapiz and concurred by all other members present;

BE IT ORDAINED BY THE SANGGUNIANG BAYAN OF LOS BAÑOS, LAGUNA, in session assembled, THAT:


SECTION 1. APPROPRIATION OF FUNDS. There is hereby appropriated from the Municipal Funds the amount of Three Million Pesos (P 3,000,000.00) to cover the grant of Gratuity Pay to Contract of Service and Job Order Employees of the Municipal Government of Los Baños for FY 2021.

SECTION 2. SOURCE OF FUNDS. The amount of Three Million Pesos (P 3,000,000.00) shall be taken from Savings of Longevity Grant for Senior Citizens as per Municipal Ordinance No. 2021-2117.


SECTION 2. EFFECTIVITY. This ordinance shall take force and effect upon approval subject to all existing auditing rules and regulations.


