**AN ORDINANCE CREATING THE POSITIONS OF TWO (2) ADMINISTRATIVE AIDE III WITH SALARY GRADE 3 AT THE MUNICIPAL PUBLIC EMPLOYMENT SERVICE OFFICE (PESO).**

**BE IT ORDAINED BY THE SANGGUNIANG BAYAN OF LOS BAÑOS, LAGUNA, in session assembled, THAT:**

**SECTION 1.** Civil Service Commission (CSC) basic qualification standards are as follows:

**EDUCATION** : Completion of two-year studies in college  
**EXPERIENCE** : None Required  
**TRAINING** : None Required  
**ELIGIBILITY** : Career Service Sub-Professional / First Level Eligibility

**SECTION 2.** The duties and responsibilities shall be as follows:

- Assists in the development of instructional materials, facilitation of learning activities, administration of tests and evaluation of student programs;
- Assists in implementation of classroom and facilities management;
- Assists in updating of curriculum, in preparing of learning manual and modules;
- Assists in the management of production activities;
- Participated in community extension program and other civic projects; and
- Performs other related functions.


**SECTION 3.** The source of funds shall be taken from the Annual Budget of CY 2022.
