ORDINANCE NO. 2022-2248

AN ORDINANCE CREATING THE POSITION OF ADMINISTRATIVE AIDE IV (CLERK II) WITH SALARY GRADE 4 AT THE TRANSPORTATION AND REGULATORY UNIT (TRU).

BE IT ORDAINED BY THE SANGGUNIANG BAYAN OF LOS BAÑOS, LAGUNA, in session assembled, THAT:

SECTION 1. Civil Service Commission (CSC) basic qualification standards are as follows:

EDUCATION : Completion of two (2) years studies in college

EXPERIENCE : None Required

TRAINING : None Required

ELIGIBILITY : Career Service (Sub-Professional) / First Level Eligibility



SECTION 2. The duties and responsibilities shall be as follows:


- Responsible in record keeping and releasing of franchise/permit to operate, issuance of MTPFRB sticker, and other pertinent records and documentation;
- Encodes all reports, documentation, and other important matters related to transportation;
- Accepts and processes the application and petition for Tricycle/Padyak/E-bike franchise/ permit to operate;
- Handles minutes/dictation, type's correspondence, receives, sorts and classifies incoming and outgoing mails, memos, circular and other similar items;
- Performs other duties as maybe necessary in the implementation of the Ordinances related to TRU.

SECTION 3. The source of funds shall be taken from the Annual Budget of CY 2022.


SECTION 4. This ordinance shall take force and effect upon approval subject to all existing auditing rules and regulations.


