**BE IT ORDAINED BY THE SANGGUNIANG BAYAN OF LOS BAÑOS, LAGUNA, in session assembled, THAT:**


**SECTION 1.** Civil Service Commission (CSC) basic qualification standards are as follows:

**EDUCATION** : Must be able to read and write

**EXPERIENCE** : None Required

**TRAINING** : None Required

**ELIGIBILITY** : None Required (MC No. 10,s.2013 Cat.III)



**SECTION 2.** The duties and responsibilities shall be as follows:


- Clearing trash, debris and contaminants from streets and curbs;
- Securely fastening vehicle attachments such as brush hogs and hydraulic hoses;
- Maintaining street sweeper vehicles and equipment by performing standard checks;
- Reporting any incidents or mechanical failures to management; and
- Other task that may be given by the Mayor, Sangguniang Bayan and supervisor.

**SECTION 3.** The source of funds shall be taken from the Annual Budget of CY 2022.

**SECTION 4.** This ordinance shall take force and effect upon approval subject to all existing auditing rules and regulations.
