ORDINANCE NO. 2022-2265

AN ORDINANCE CREATING THE POSITION OF REGISTRATION OFFICER III WITH SALARY GRADE 18 AT THE MUNICIPAL CIVIL REGISTRY OFFICE.

BE IT ORDAINED BY THE SANGGUNIANG BAYAN OF LOS BAÑOS, LAGUNA, in session assembled, THAT:

SECTION 1. Civil Service Commission (CSC) basic qualification standards are as follows:

EDUCATION : Bachelor's Degree
EXPERIENCE : Two (2) years of relevant experience
TRAINING : Eight (8) hours of relevant training
ELIGIBILITY : Career Service Professional /
Second Level Eligibility

SECTION 2. The duties and responsibilities shall be as follows:


- Checks and reviews Civil Registry Documents (CRDS) such as certificates of Birth, Death, and Marriage for registration;
- Checks and reviews monthly report of CRDS duplicates to be forwarded to the Provincial Statistics Office as well as the annual budget proposal;
- Receives and process court decrees: annulment, adoption of minors, legal separation, correction of entry and Foreign Divorce Recognition/Shari a;
- Processes, evaluates and reviews Petitions for Corrections (RA 9048 / RA 10172) and MC 2010-04, AUSF, Legitimation, Out-of-Town Delayed Registration and Supplemental Reports;
- Check and reviews application for Marriage License;
- Signs Certified True Copies and transcriptions of CRDS;
- Monitor the tracking for Data Monitoring System (DMS);
- Checks and reviews preparation of purchase requests and purchase orders;
- Prepares OPCR and IPCR;
- Supervises BREQS, Transcription, Scanning and digitization of CRDS;
- Monitors and evaluates CRD registration;
- Facilitates learning and development trainings / workshops / symposium;
- Attends and participates in the training, workshops, conventions, among others;
- In-charge of Office in the absence of the Municipal Civil Registrar (MCR); and
- Perform such other functions as may be prescribed by the head of the office.

SECTION 3. The source of funds shall be taken from the Annual Budget of CY 2022.

SECTION 4. This ordinance shall take force and effect upon approval subject to all existing auditing rules and regulations.
