ORDINANCE NO. 2022 - 2275

ORDINANCE ENACTING THE SUPPLEMENTAL BUDGET IN THE TOTAL AMOUNT OF FORTY-TWO MILLION TWO HUNDRED NINETY-SEVEN THOUSAND SEVEN HUNDRED FIFTY-FOUR PESOS AND 53/100 (P 42,297,754.53) CHARGEABLE AGAINST THE BEGINNING BALANCE FOR CY 2022.

WHEREAS, in his letter dated February 07, 2022, the Local Chief Executive, Honorable Mayor Antonio L. Kalaw has requested the august body for the enactment of a Supplemental Budget chargeable against the Beginning Balance for CY 2022;

WHEREAS, for the **Office of the Sangguniang Bayan**, the expenses refer to the hiring of additional ten (10) job orders to augment workforce of the members of the Sangguniang Bayan;



WHEREAS, for the **General Service Office**, the requested amount will be utilized for the following: (1) Survey of donated parcels of land in various areas within the Municipality; (2) Payment of installation cost of water utilities in vital municipal structures; (3) Purchase of lot for relocation area of informal settler families to be affected by local and national government development projects;

WHEREAS, for the **Municipal Accounting Office**, expenses refer to purchase of motor vehicle to expedite work performance;

WHEREAS, for the **Bid and Awards Committee**, the amount shall augment collections from sale of bid documents to defray payment of administrative cost;

WHEREAS, for the **Office of the Municipal Agriculturist, Office of the Municipal Engineer and Information and Communication System Office**, the amount pertains to payment of prior year expenditures left out for various reasons during the deadline for the closing of books of accounts of the Municipal Government;

SECTION 2. EFFECTIVITY. This ordinance shall take force and effect upon approval subject to all existing auditing rules and regulations.


