
ORDINANCE NO. 2022 - 2294

ORDINANCE APPROVING THE SUPPLEMENTAL BUDGET NO. 1 OF BARANGAY MAYONDON, LOS BAÑOS, LAGUNA FOR THE YEAR 2022 IN THE AMOUNT OF THREE HUNDRED THOUSAND PESOS AND 00/100 ONLY (P 300,000.00).

BE IT ORDAINED BY THE SANGGUNIANG BAYAN OF LOS BAÑOS, LAGUNA, in session assembled, THAT:

SECTION 1. TITLE – Ordinance approving the Supplemental Budget No. 1 of Barangay Mayondon, Los Baños, Laguna for the year 2022 in the amount of Three Hundred Thousand Pesos and 00/100 only (P 300,000.00);

SECTION 2. COVERAGE – The amount of Three Hundred Thousand Pesos and 00/100 (P 300,000.00) of Barangay Mayondon, Los Baños, Laguna shall cover the expenses for **MOOE** : Provision of food and non-food items to marginalized sector affected by COVID-19 Pandemic - P 300,000.00;

SECTION 3. SOURCE OF FUNDS – The amount of Three Hundred Thousand Pesos and 00/100 (P 300,000.00) of Barangay Mayondon, Los Baños, Laguna shall be sourced from the Realignment / Reversion / Reprogramming of 20% BDF : Riprapping of retaining walls at Punong Bundok, Purok 5;

SECTION 4. CERTIFICATION OF BUDGETARY ALLOCATION – The statement of fund actually available has been certified correct by the Barangay Treasurer based on year 2019 and the Municipal Accountant in accordance with the provision of Section 474 (b-4) of R. A. 7160;


SECTION 5. EFFECTIVITY – This ordinance shall take force and effect upon approval subject to all existing auditing rules and regulations.
