
ORDINANCE ADOPTING REPUBLIC ACT NO. 11310, "AN ACT INSTITUTIONALIZING THE PANTAWID PAMILYANG PILIPINO PROGRAM (4PS)" IN THE MUNICIPALITY OF LOS BAÑOS.

WHEREAS, the Republic Act 11310 entitled, "An Act Institutionalizing the Pantawid Pamilyang Pilipino Program (4Ps) was signed into law on July 23, 2018;

WHEREAS, in adherence to the 4Ps Law, Department of Social Welfare and Development (DSWD) and partner Local Government Units (LGUs) are enjoined to have clear and targeted programs for the beneficiaries ensuring that their well being is improved and not slide back to poverty;

WHEREAS, the DSWD shall advocate for the implementation of 4Ps as the national poverty reduction and a human capital investment program that provides conditional cash transfer to qualified household beneficiaries;



2.00 Ordinance No. 2022-2299 04/01/2022

WHEREAS, DSWD will identify and select the target household - beneficiaries on the basis of a uniform, objective and transparent selection process as indicated in Section 5 of Republic Act No. 11310 otherwise known as the Pantawid Act (*Section 5. Selection of Qualified Household-Beneficiaries. On a nationwide basis, the DSWD shall select qualified household-beneficiaries of the 4Ps using a standardized targeting system. It shall conduct a regular revalidation of beneficiary targeting every three (3) years.*);

WHEREAS, part of the responsibilities of the Municipal Government of Los Baños (MGLB) is to take the lead and facilitate the passage of Local Ordinance supporting the program implementation of 4Ps to improve the condition of its poor constituents;


WHEREAS, the Sangguniang Bayan after thorough discussion unanimously assented to adopt in toto the provisions of the RA 11310 entitled “An Act Institutionalizing the Pantawid Pamilyang Pilipino Program (4Ps);

NOW THEREFORE, on motion of Councilor Miko C. Pelegrina duly seconded by Councilor Janos S. Lapiz and approved by the councilors present;


RESOLVED, AS IT IS RESOLVED, An Ordinance Adopting the Republic Act 11310, “An Act Institutionalizing the Pantawid Pamilyang Pilipino Program (4Ps) in the Municipality of Los Baños;


