ORDINANCE APPROVING THE SANGGUNIANG KABATAAN ANNUAL BUDGET OF BARANGAY TIMUGAN, LOS BAÑOS, LAGUNA FOR THE YEAR 2022 IN THE AMOUNT OF EIGHT HUNDRED TWENTY ONE THOUSAND ONE HUNDRED FIFTY SEVEN PESOS AND 90/100 ONLY (P 821,157.90).


WHEREAS, the Sangguniang Kabataan of Barangay Timugan, Los Baños, Laguna has prepared and submitted their 2022 Annual Budget for approval by the Sangguniang Bayan;

WHEREAS, the said Annual Budget for the year 2022 of Sangguniang Kabataan of Barangay Timugan, was supported by a Resolution;

WHEREAS, the Annual appropriation intended for 10% SK Fund shall be provided in accordance with RA 10742 otherwise known as SK Reform Act;

WHEREAS, the Sangguniang Kabataan Annual Budget of Barangay Timugan with the corresponding amount, as stated above, has been certified by the Punong Barangay;

WHEREAS, the SK Annual Budget, which is the financial plan embodying the estimates of the income and expenditures of the SK for one (1) fiscal year, shall be prepared in accordance with the approved Annual Barangay Youth Investment Plan (ABYIP);



WHEREAS, the budget of Sangguniang Kabataan of Barangay Timugan has been appropriated for expenditures for General Administration Program: Maintenance and Other Operating Expenses; Capital Outlay; Sangguniang Kabataan Development and Empowerment Programs such as Health and Nutrition; Education; Economic Empowerment; Social Inclusion and Equity; Peace, Building and Security; Governance; Active Citizenship; Environment and Global Mobility; the details of which are contained in their Annual Budget Proposal;

WHEREAS, the Sangguniang Kabataan Annual Budget of Barangay Timugan, Los Baños, Laguna was studied and reviewed by the Local Finance Committee pursuant to the provisions setforth by R.A. 7160 otherwise known as the Local Government Code;

NOW THEREFORE, on motion of Councilor Geronimo A. Ciceron duly seconded by Councilor Cris Dayril B. Bagnes and concurred by all other members present;

BE IT ORDAINED BY THE SANGGUNIANG BAYAN OF LOS BAÑOS, LAGUNA, in session assembled, THAT:


SECTION 1. SHORT TITLE – This ordinance shall be known as an Ordinance approving the Sangguniang Kabataan Annual Budget of Barangay Timugan, Los Baños, Laguna for the year 2022 in the amount of Eight Hundred Twenty One Thousand One Hundred Fifty Seven Pesos and 90/100 Only (P 821,157.90).

SECTION 2. COVERAGE – This ordinance covers the 2022 Sangguniang Kabataan Annual Budget of Barangay Timugan.


SECTION 3. EFFECTIVITY – This ordinance shall take force and effect upon approval subject to all existing auditing rules and regulations.


