ORDINANCE NO. 2023-2362

AN ORDINANCE NAMING THE THREE (3) ROAD LOTS DONATED BY THE HEIRS OF ANTONIO DIGAL BUSTRILLOS AND NENA ROLA BUSTRILLOS TO BAGONG LOS BAÑOS ROAD 1; BAGONG LOS BAÑOS ROAD 2; AND BAGONG LOS BAÑOS ROAD 3 CONTAINING AN AREA OF SIX THOUSAND TWO HUNDRED EIGHTY (6,280) SQUARE METERS LOCATED IN BARANGAY ANOS, LOS BAÑOS, LAGUNA.

WHEREAS, in his letter dated March 27, 2023, the Local Chief Executive Honorable Mayor Anthony F. Genuino requested the august body for the naming of the three (3) road lots donated by the heirs of Antonio Digal Bustrillos and Nena Rola Bustrillos to Bagong Los Baños Road 1; Bagong Los Baños Road 2; and Bagong Los Baños Road 3 respectively, containing an area of Six Thousand Two Hundred Eighty (6,280) Square Meters located in Barangay Anos, Los Baños, Laguna;

WHEREAS, the three (3) Road Lots in the name of Mr. Antonio Digal Bustrillos married to Nena Rola Bustrillos , covered by Transfer Certificate of Titles (TCT): **T-34019** (Tax Dec. No. 0002-01086) with an area of Fifty-Six (56) square meters; **T-34020** (Tax Dec. No. 0002-01064) with an area of Four Thousand Five Hundred Ninety-Two (4,592) square meters; **T-34021** (Tax Dec. No. 0002-01100) with an area of One Thousand Six Hundred Thirty-Two (1,632) square meters are strategically located, leading to the new cemetery area and adjacent to parts of Marymount Village and Lopez Heights;

WHEREAS, on March 15, 2021, through a Municipal Resolution No. 2021- 49, the Municipal Government of Los Baños accepted the Donation made by the heirs of Antonio Digal Bustrillos and Nena Rola Bustrillos, namely Alfinetta Rola Bustrillos - Zamora; Arelyne Bustrillos - Pacho; Aryelita Bustrillos - Carpio; and Mikel Angelo Bustrillos Yap (Son of their Deceased sister Aleli Bustrillos - Yap);

WHEREAS, streets, avenues, boulevards, parks, playgrounds, historical spots and other public places are named to signify, perpetuate the greatness and nobility of certain personages of note or the significance of certain events;

WHEREAS, to avoid confusion from the motorist and postal service, it is imperative to name the said Road lots ;


WHEREAS, the Sangguniang Bayan has the authority to name / change the name of barangay roads, avenues, boulevards, thoroughfares, and bridges pursuant to Section 13 of the Local Government Code;

WHEREAS, after careful review and deliberation, the Sangguniang Bayan agreed to name the aforementioned donated road lots to Bagong Los Baños Road 1, Bagong Los Baños Road 2, and Bagong Los Baños Road 3, respectively;

NOW THEREFORE, on motion of Councilor Jonathan Bryan S. Siytiap duly seconded by Councilor Benedicto S. Alborida and Councilor Mike Dexter A. Concio and unanimously approved by all the councilors present;

BE IT ORDAINED BY THE SANGGUNIANG BAYAN OF LOS BAÑOS, LAGUNA, in session assembled, **THAT**:

SECTION 1. TITLE. This Ordinance shall be known as an Ordinance naming the Three (3) Road Lots Donated by the heirs of Antonio Digal Bustrillos and Nena Rola Bustrillos to Bagong Los Baños Road 1; Bagong Los Baños Road 2; And Bagong Los Baños Road 3 containing an area of Six Thousand Two Hundred Eighty (6,280) square meters located in Barangay Anos, Los Baños, Laguna.



SECTION 2. NAMING OF DONATED ROADS. The Three Road Lots donated by the heirs of Antonio Digal Bustrillos and Nena Rola Bustrillos shall be name as follows:

Road Lot 1 to **Bagong Los Baños Road 1**
Road Lot 2 to **Bagong Los Baños Road 2**
Road Lot 3 to **Bagong Los Baños Road 3**


SECTION 3. SEPARABILITY CLAUSE. If, for any reasons, any part or provision of this Ordinance shall be declared unconstitutional or invalid by the court, or suspended or revoked by competent authorities, other parts or the provisions thereof which are not affected thereby shall continue to be full force and effect.

SECTION 4. REPEALING CLAUSE. All ordinances, rules and regulations or parts thereof not consistent with any provision of this Ordinance are hereby repealed, amended or modified accordingly.


SECTION 5. EFFECTIVITY. This Ordinance shall take force and effect upon approval.
