ORDINANCE NO. 2023-2369

AN ORDINANCE AMENDING ORDINANCE NO. 2022-2315 ENTITLED "AN ORDINANCE AMENDING SECTION 4 OF THE MUNICIPAL ORDINANCE NO. 2007-663 DATED SEPTEMBER 3, 2007 ENTITLED 'ORDINANCE INSTITUTIONALIZING THE ANNUAL BANAMOS FESTIVAL OF THE MUNICIPALITY OF LOS BANOS, LAGUNA.'"

WHEREAS, the Municipality of Los Baños annually celebrates the Bañamos Festival in conjunction with its Founding Anniversary;

WHEREAS, all activities and/or festivities, whether primary or ancillary, to be conducted during the Bañamos Festival are hereby approved and authorized;

WHEREAS, the implementation of activities and/or festivities is delegated to different Committees headed by an Event Coordinator and a Co-coordinator who are hereby authorized to make each activity and/or festivity successful through various efforts as provided by Section 2 of Ordinance No. 2007-663;

WHEREAS, all booth spaces, whether complimentary or leasable, to be located within the Carnival Fair and Hot Air Balloon Fiesta & Trade Fair grounds are likewise hereby approved and authorized, *provided* that payments for leasable booth spaces collected/solicited pursuant to Section 3 of Ordinance No. 2007-663 shall be remitted and paid solely and directly to the Municipal Treasury;

WHEREAS, all donations, solicitations, and payments in relation to the activities and/or festivities of the Bañamos Festival shall similarly be accepted and duly acknowledged by the Municipal Treasury in accordance with Section 3 of Ordinance No. 2007-663;

WHEREAS, after careful review and deliberation of the Sangguniang Bayan Members, they approved the further amendment of Section 4 of the Municipal Ordinance No. 2007-663, as amended by Ordinance No. 2022-2315;

NOW THEREFORE, on motion of Councilor Jonathan Bryan S. Siytiap, duly seconded by Hon. Jerwin A. Moliñawe and concurred by all Councilors present;

BE IT ORDAINED BY THE SANGGUNIANG BAYAN OF LOS BAÑOS, LAGUNA, in session assembled, **THAT**:

SECTION 1. TITLE. This Ordinance shall be known as “An Ordinance Amending Ordinance No. 2022-2315 entitled “An Ordinance Amending Section 4 of the Municipal Ordinance No. 2007-663 dated September 3, 2007 entitled ‘Ordinance Institutionalizing the Annual Bañamos Festival of the Municipality of Los Baños, Laguna’.”

SECTION 2. AMENDMENT. Section 4 of Municipal Ordinance No. 2007-663 is hereby further amended, to wit:

SECTION 4. Any savings and all forms of collections derived /generated through solicitation and other activities in celebration of the Bañamos Festival shall be placed in a Trust Fund Account to be utilized in the current year’s Bañamos Festival, except for the following and every year thereafter:

- a. Entire proceeds from the PADYAK LB Registration which shall be used for Los Baños Women in Cancer Protection, Early Detection and Treatment Program; and*
- b. Proceeds from the FUN RUN Registration to be shared and payable to the organizer at Eighty Pesos (P 80.00) and the LGU at One Hundred Seventy Pesos (P 170.00) per participant, the LGU share of which shall be used for the Program for Dialysis Patients in Los Baños.*

SECTION 4. Any savings and all forms of collections derived /generated through solicitation and other activities in celebration of the Bañamos Festival shall be placed in a Trust Fund Account to be utilized in the annual Bañamos Festival activities, except for the following and every year thereafter:

- a. Entire proceeds from the PADIYAK LB Registration which shall be used for Los Baños Women in Cancer Protection, Early Detection and Treatment Program;
- b. Proceeds from the FUN RUN / COLOR RUN Registration which shall be used for the Program for Dialysis Patients in Los Baños; and
- c. Proceeds from the CARNIVAL FAIR which shall be used to support and promote the activities and programs of the Office of the Senior Citizens Affairs (OSCA) for the benefit and welfare of the senior citizens of Los Baños.


SECTION 3. SEPARABILITY CLAUSE. If for any reasons, a part or provisions of this Ordinance which shall be held to be unconstitutional or invalid, other parts or provisions hereof which are not affected shall continue to be in full force and effect.

SECTION 4. REPEALING CLAUSE. All ordinances, rules and regulations or parts not consistent with any provision of this Ordinance are hereby repealed, amended or modified accordingly.


SECTION 5. EFFECTIVITY. This Ordinance shall take force and effect upon approval.
