**ORDINANCE NO. 2023-2371**

**AN ORDINANCE AMENDING SECTION 3 OF ORDINANCE NO. 2023-2368 ENTITLED “AN ORDINANCE ESTABLISHING THE BAGONG LOS BAÑOS EDUCATIONAL ASSISTANCE PROGRAM IN THE MUNICIPALITY OF LOS BAÑOS, LAGUNA”**

**BE IT ORDAINED BY THE SANGGUNIANG BAYAN OF LOS BAÑOS, LAGUNA**  
in session assembled, **THAT:**

**SECTION 1.** Section 3 of Ordinance No. 2023-2368 which states:

**SECTION 3. GENERAL QUALIFICATIONS OF BENEFICIARIES**  
– *To be an eligible beneficiary of the Bagong Los Baños Educational Assistance Program, the following requisites must be present:*

- 1. Student applicant must be a bona fide resident of Los Baños, Laguna; and*

2. For Grades 7 to 12, the student applicant must be enrolled in a public or private school in Los Baños, Laguna. For College, the student applicant must be enrolled in a private, local, or state college/university within Laguna.

*shall be amended, as follows:*

**SECTION 3. GENERAL QUALIFICATIONS OF BENEFICIARIES**

– To be an eligible beneficiary of the Bagong Los Baños Educational Assistance Program, the following requisites must be present:

1. Student applicant must be a bona fide resident of Los Baños, Laguna; and
2. For Grades 7 to 12, the student applicant must be enrolled in a public or private school in Los Baños, Laguna except students residing in Barangay Bagong Silang and Barangay Tadalac who may be enrolled in the nearest public or private school in the Municipality of Bay and City of Calamba, respectively.

For College, the student applicant must be enrolled in a private, local, or state college/university within Laguna.


**SECTION 2. REPEALING CLAUSE.** All ordinances, rules and regulations or parts not consistent with any provision of this Ordinance are hereby repealed, amended or modified accordingly.


**SECTION 3. SEPARABILITY CLAUSE.** If, for any reasons, any part or provision of this Ordinance shall be declared unconstitutional or invalid by the court, or suspended or revoked by competent authorities, other parts or the provisions thereof which are not affected thereby shall continue to be full force and effect.


**SECTION 4. EFFECTIVITY.** This Ordinance shall retroact from the date of effectivity of Ordinance No. 2023-~~2368~~. *g*
