ORDINANCE NO. 2023-2379

AN ORDINANCE REVERTING THE AMOUNT OF FOUR HUNDRED THOUSAND PESOS (P 400,000.00) FROM MAINTENANCE AND OTHER OPERATING EXPENSE – TRAINING EXPENSES TO CAPITAL OUTLAY – WATER SUPPLY SYSTEM UNDER THE 5% MUNICIPAL DISASTER RISK REDUCTION AND MANAGEMENT FUND CURRENT APPROPRIATION.

WHEREAS, in his letter dated October 18, 2023, the Local Chief Executive Honorable Mayor Anthony F. Genuino urgently requested the august body for the passage / enactment of appropriate legislative measures for a Supplemental Budget for the reversion of fund amounting to Four Hundred Thousand Pesos (P400,000.00) from Maintenance and Other Operating expense – Training Expenses to Capital Outlay – Water Supply System under the 5% Municipal Disaster Risk reduction and Management Fund Current Appropriation;

WHEREAS, below is the summary of expenditures for the reversion of fund amounting to Four Hundred Thousand Pesos (P400,000.00), to wit:

WHEREAS, the item refers to the reversion of fund from Maintenance and Other Operating Expense – Training Expenses to Capital Outlay – Augmentation for Water Supply System under the 5% Municipal Disaster Risk Reduction and Management Fund Current Appropriation;

WHEREAS, after careful review and deliberation of the Sangguniang Bayan Members, the august body agreed on the needed reversion of fund:

NOW THEREFORE, on motion of Councilor Jonathan Bryan S. Siytiap, duly seconded by Councilor Benedicto S. Alborida and approved by all the councilors present;

BE IT ORDAINED BY THE SANGGUNIANG BAYAN OF LOS BAÑOS, LAGUNA, in session assembled, **THAT**:

SECTION 1. REVERSION OF FUND. The amount appropriated for the Training Expenses from Maintenance and Operating Expense are reverted as follows:

From :

MAINTENANCE AND OPERATING EXPENSE

Training Expenses:

Basic Occupational Safety Hazards Training for Municipal Employees (BOSH) P 225,000.00

Emergency Medical Technician Basic (EMT-B) Training for MHO and MDRRMO 175,000.00

To:

CAPITAL EXPENSE

Water Supply System:

Safe Water in times of Disaster (Los Baños Water Supply Facility) 400,000.00

SECTION 2. SEPARABILITY CLAUSE. If for any reasons, a part or provisions of this Ordinance which shall be held to be unconstitutional or invalid, other parts or provisions hereof which are not affected shall continue to be in full force and effect.

SECTION 3. REPEALING CLAUSE. All previous issuances, ordinances, rules and regulations or parts thereof not consistent with any provision of this Ordinance are hereby repealed, amended or modified accordingly.


SECTION 4. EFFECTIVITY. This ordinance shall take force and effect upon approval subject to all existing auditing rules and regulations.
