ORDINANCE NO. 2023-2382

AN ORDINANCE AMENDING THE TITLE AND SECTION 1 OF MUNICIPAL ORDINANCE NO. 2022-2336 ENTITLED “AN ORDINANCE APPROVING THE CONDUCT OF DISYEMBRE NA SA BAGONG LOS BAÑOS TRADE FAIR FOR THE PERIOD OF DECEMBER 1, 2022 -JANUARY 15, 2023 AND THE COLLECTION OF RENTAL FEES FOR THE LEASE OF TRADE FAIR BOOTHS” TO THE PERIOD OF EVERY DECEMBER OF THE YEAR.

WHEREAS, “Disyembre na sa Bagong Los Baños” is a program for the incoming holiday and year end celebration of the Municipality of Los Baños. Several activities will be conducted during the “Disyembre na sa Bagong Los Baños” such as but not limited to Gitaharana Acoustic Contest, Barangay Chorale Competition, Lighting Ceremony of Christmas Tree and Christmas Village, Trade Fair and Carnival Rides; *hcc*

WHEREAS, one of the activities lined up is the Trade Fair where merchants, cooperatives, businesses and enterprises in the Municipality are encouraged to join and showcase their products and services;

WHEREAS, on November 8, 2022, the Sangguniang Bayan enacted Ordinance No. 2022-2336 providing for the conduct of Disyembre na sa Bagong Los Baños Trade Fair and the Collection of Rental Fees for the Lease of Trade Fair Booths;

WHEREAS, in his letter dated November 21, 2023, the Honorable Mayor Anthony F. Genuino urgently requested the august body to amend Ordinance No. 2022-2336;

WHEREAS, after careful review and deliberation, the Sangguniang Bayan agreed to approve the request of the Local Chief Executive;

NOW THEREFORE, on motion of Councilor Jonathan Bryan S. Siytiap, duly seconded by Councilor Jerwin A. Moliñawe and approved by all the councilors present;

BE IT ORDAINED BY THE SANGGUNIANG BAYAN OF LOS BAÑOS, LAGUNA in session assembled, **THAT**:

SECTION 1. AMENDMENTS. The title and Section 1 of Ordinance No. 2022-2336 are hereby amended as follows:

- a. **TITLE.** AN ORDINANCE APPROVING THE CONDUCT OF “DISYEMBRE NA SA BAGONG LOS BAÑOS” TRADE FAIR FOR THE PERIOD DECEMBER 1, 2022 TO JANUARY 15, 2023 AND THE COLLECTION OF RENTAL FEES FOR THE LEASE OF TRADE FAIR BOOTHS.

shall now read as :

TITLE. “AN ORDINANCE APPROVING THE CONDUCT OF DISYEMBRE NA SA BAGONG LOS BAÑOS TRADE FAIR FOR THE PERIOD OF EVERY DECEMBER OF THE YEAR”

- b. **Section 1. DISYEMBRE NA SA BAGONG LOS BAÑOS TRADE FAIR.** *The conduct of Disyembre na sa Bagong Los Baños Trade Fair for the period December 1, 2022 to January 15, 2023 is hereby approved and authorized.*

SECTION 1. DISYEMBRE NA SA BAGONG LOS BAÑOS TRADE FAIR. The conduct of Disyembre na sa Bagong Los Baños Trade Fair for the period of **DECEMBER 2023 AND EVERY YEAR THEREAFTER** is hereby authorized and approved.

SECTION 2. APPLICABILITY OF ORDINANCE NO. 2022-2336. Section 2 and 3 of Ordinance No. 2022-2336 which are not inconsistent with this Ordinance and are not expressly modified, revoked or repealed in this Ordinance shall continue to be in full force and effect.


SECTION 3. REPEALING CLAUSE. All ordinances contrary to or inconsistent with this Ordinance are hereby repealed or modified accordingly.

SECTION 4. SEPARABILITY CLAUSE. If, for any reasons, any part or provision of this Ordinance shall be declared unconstitutional or invalid by the court, or suspended or revoked by competent authorities, other parts or the provisions thereof which are not affected thereby shall continue to be in full force and effect.


SECTION 5. EFFECTIVITY CLAUSE. This Ordinance shall take effect immediately upon its approval.
