ORDINANCE NO. 2019-1913

AN ORDINANCE CREATING THE BARANGAY NUTRITION COMMITTEE IN EVERY BARANGAY IN THE MUNICIPALITY OF LOS BAÑOS.

WHEREAS, the Local Government Unit of Los Baños aims to provide a robust implementation of nutritional programs and projects in all the fourteen (14) Barangays of the Municipality of Los Baños with the assistance from the creation of the Barangay Nutrition Committee;

WHEREAS, Presidential Decree 1569 was enacted to strengthen the Barangay Nutrition Program by providing the Barangay Nutrition Scholars (BNS) is a barangay-based volunteer worker who delivers basic nutrition and related health services, and links communities with nutrition and relates service provider;

WHEREAS, the Municipality of Los Baños has available programs and projects that aim to reduce malnutrition and other health and nutrition problem that afflict susceptible groups of people from different sectors and offices;

WHEREAS, the Barangay Nutrition Committee shall ~~upkeep~~ with the constant rise in malnutrition as such the Barangay Nutrition Committee shall create ~~and~~ implement programs that

shall eliminate malnutrition in their respective Barangays as directed by the Local Government Unit of Los Baños;

NOW THEREFORE, on motion of Councilor Josephine S. Evangelista duly seconded and approved by the Councilors present;

BE IT ORDAINED BY THE SANGGUNIANG BAYAN OF LOS BAÑOS, LAGUNA IN SESSION ASSEMBLED, THAT:

SECTION 1. TITLE - This ordinance shall be called as “AN ORDINANCE CREATING THE BARANGAY NUTRITION COMMITTEE IN EVERY BARANGAY IN THE MUNICIPALITY OF LOS BAÑOS”;

SECTION 2. COVERAGE - This ordinance shall govern all objects situated within the territorial jurisdiction of Los Baños, specifically enumerated in its provisions, and all persons, entities or agencies involved in activities or related fields which are made subject of regulation by the provisions embodied in this code.

SECTION 3. DECLARATION OF POLICY - It is hereby declared to be the policy of the Local Government of Los Baños to be fully committed in creating the Barangay Nutrition Committee to adhere in leading and promoting health and nutrition awareness in all barangays of the Municipality of Los Baños.

SECTION 4. LEGAL BASIS - This ordinance shall be governed by the provisions of the following acts of the State:

- a. Presidential Decree 1569 – Strengthening the Barangay Nutrition Program by Providing for a Barangay Nutrition Scholar in Every Barangay, Providing Funds Therefor, and For Other Purposes;
- b. Senate Bill No. 2397 – An Act Creating the Position of Barangay Nutrition Worker in Every Barangay Providing Incentives Thereto, Appropriating Funds Therefor, Amending For the purpose Presidential Decree No. 1569; and
- c. DILG Memorandum Circular No. 2015-19 – Guidelines on Establishing a Database on Functional Local Nutrition Committee;
- d. DILG Memorandum Circular No. 2018-42 – Adoption and Implementation of the Philippine Plan of Action for Nutrition (PPAN) 2017-2022.

SECTION 5. COMPOSITION OF THE BARANGAY NUTRITION COMMITTEE
- The Barangay Nutrition Committee shall be composed of the following:

Chairperson: Barangay Captain
Vice Chairperson: Barangay Nutrition Scholar, President

Members:

Committee Chairperson on Health and Nutrition of the Sangguniang Barangay
Sangguniang Kabataan Chairperson
Barangay Day Care Head
RIC Head
Barangay Mid wife
Barangay Nutrition Scholars and Volunteers
Barangay Health Workers and Volunteers

School Principals from schools within the barangay
Representation from Non-government organization within
the Barangay.


SECTION 6. GUIDELINES ROLES AND RESPONSIBILITIES OF THE BARANGAY NUTRITION COMMITTEE - The Barangay nutrition Committee shall adhere to the guidelines stipulated hereunder:

- a. Shall construct set criteria in determining health and nutrition development in their respective Barangay;
- b. Shall create Barangay Nutritional Action plan for the community;
- c. Ensure appropriate budgeting of funds for proper use for programs, project, seminars and trainings;
- d. Establish a systematic monitoring of various health and nutrition cases, projects, and programs;
- e. Efficiently and effectively implement and manage nutrition programs and action plans established by the Local Government Unit of Los Baños;
- f. Sustain nutrition community-based activities;
- g. Ensure proper dissemination of information regarding health and nutrition programs in their respective Barangay;
- h. Ensure proper documentation and submit reports of program and project outcomes to the Municipal Nutrition Action Office regularly every month;
- i. Complete basic training course for Barangay Nutrition Scholars;
- j. Attend regular meetings pertaining to Nutrition plans, programs and project as mandated by the Local Government Unit of Los Baños;
- k. Conduct Nutritional Assessment and Report for respective projects and programs assigned;
- l. Conduct educational nutrition activities;
- m. Deliver nutrition related services such as but not limited to counselling on nutrition, act as support group, supplementation to undernourished and malnourished persons in the community and supervised nutrition intervention; and
- n. Conduct home visits, follow-ups, monitoring and evaluation;

SECTION 7. SOURCE OF FUNDS -The source of funds for the implementation of programs, projects, trainings and activities of the Barangay Nutrition Committee shall be taken and appropriated from the respective Barangay Annual Budget.

SECTION 8. REPEALING CLAUSE - All ordinances, rules and regulations or parts not consistent with any provision of this ordinance are hereby repealed, amended or modified accordingly.

SECTION 9. SEPARABILITY CLAUSE - If, for any reasons, any part or provision of this ordinance shall be declared unconstitutional or invalid by the court, or suspended or revoked by competent authorities, other parts or the provisions thereof which are not affected thereby shall continue to be full force and effect.
