RESOLUTION DECLARING POWER K CONSTRUCTION SUPPLY & SERVICES INELIGIBLE TO BID AND FAILURE OF BIDDING FOR THE REHABILITATION OF BARANGAY MRF (CONCRETING, FENCING, ROOFING) PHASE II, TIMUGAN, LOS BAÑOS, LAGUNA

WHEREAS, Power K Construction Supply & Services was the only bidder who participated in the bidding on January 25, 2022 for the Rehabilitation of Barangay MRF (Concreting, Fencing, Roofing) Phase II, Timugan, Los Baños, Laguna;

WHEREAS, Power K Construction Supply & Services was declared ineligible to bid due to non-submission of updated Mayor's Permit as provided by Section 23.1 (ii) of the Revised IRR of R.A. No. 9184;

WHEREAS, Section 35.1(b) of the Revised IRR of R.A. 9184 states that the Bids and Awards Committee shall declare the bidding a failure when all prospective bidders are declared ineligible;

THEREFORE, for and in consideration of the foregoing, we, members of the Bids and Awards Committee, hereby **RESOLVE AS IT IS HEREBY RESOLVED**:

- a. To declare of Power K Construction Supply & Services ineligible to bid for the Rehabilitation of Barangay MRF (Concreting, Fencing, Roofing), Phase II, Timugan, Los Baños, Laguna; and
- b. To declare failure of bidding for the aforementioned project.
