RESOLUTION NO. 2022-010

WHEREAS, Section 7 of Republic Act No. 9184 and its revised Implementing Rules and Regulations (IRR) mandates the preparation of the Annual Procurement Plan (APP) which should include procurements considered crucial to the efficient discharge of governmental functions;

WHEREAS, Advisory 01-2022 issued by the Government Procurement Policy Board-Technical Support Office (GPPB-TSO) reminded the submission of Procurement Reports for 2022 which includes the submission of APP on or before January 31, 2022;

WHEREAS, the APP is a requisite mandatory document that the agency must prepare to reflect the entire procurement activities for goods and services and infrastructure that it plans to undertake within the calendar year;

WHEREAS, a BAC Resolution shall no longer be required for each transaction provided that the machine copy of the PPMP and APP page where the PPA is indicated is attached to the Purchase Request (PR) as per local Memorandum Order No. ALK-2021-096;


WHEREAS, any changes in the approved and adopted APP shall be supported by a Supplemental Procurement Plan and Supplemental PPMP;


WHEREAS, the BAC unanimously agreed to accept the APP and PPMP as submitted by all the offices of the municipal government in toto and further consolidated by the Secretariat for endorsement to GPPB;
