RESOLUTION DECLARING 1st FAILURE OF SMALL VALUE PROCUREMENT (SVP)

WHEREAS, there was an approved Approved Budget for the Contract of One Hundred Twenty Thousand Six Hundred Pesos and 00/100 (P 120,600.00) for the Supply and Delivery of ICT Equipment for Office of the Mayor, Los Baños, Laguna;

WHEREAS, Section 53 of the Revised Implementing Rules and Regulations (IRR) of R.A. 9184 otherwise known as the Government Procurement Reform Act allows an agency to resort to negotiated procurement;

WHEREAS, further, Section 53.9 of the Revised IRR of R.A. 9184 allows an agency to resort to Small Value Procurement where the amount involved does not exceed the threshold prescribed in Annex "H" of the revised IRR, provided, that in case of goods the procurement does not fall under shopping in Section 52 of the IRR;

WHEREAS, the BAC, thru its Secretariat has undertaken the following activities:


1. Posted Request for Quotation at the Philippine Government Electronic Procurement System (PhilGEPS) and on the bulletin board of the Municipality last February 10, 2022 and set the deadline of submission of quotations on February 14, 2022;
2. Requested quotations from eight (8) suppliers of known qualifications, namely:
 - a. Masangkay Computer Center of Sta. Cruz, Manila;
 - b. Rand Computer Center of Los Baños, Laguna;
 - c. AA-3S General Merchandise of Sta. Cruz, Laguna;
 - d. Shmic General Merchandise of Quezon City;
 - e. Mendo Enterprises of Quezon City;
 - f. Bitslink Computers of San Pablo, Laguna;
 - g. SMS Marketing of Los Baños, Laguna; and
 - h. Ja Laron Trading of Calamba City, Laguna
3. No quotations were received during the opening last February 15, 2022;

WHEREAS, Section 35.1(a) of the Revised IRR of R.A. 9184 provides that the Bids and Awards Committee shall declare the bidding a failure when no bid is received;

NOW, THEREFORE, We, the Member of the Bids and Awards Committee, hereby **RESOLVE** as it is hereby **RESOLVED**;

1. To declare the 1st FAILURE OF SMALL VALUE PROCUREMENT for the Supply and Delivery of ICT Equipment for Office of the Mayor, Los Baños, Laguna due to absence of participating supplier; and
2. To endorse this to the General Services Office (GSO) to handle the procurement of the project, Supply and Delivery of ICT Equipment for Office of the Mayor, Los Baños, Laguna due to urgency so as not to hamper the smooth operations of the requesting office.
