RESOLUTION NO. 2022-056

RESOLUTION SUSPENDING THE INTERNAL RULE OF THE BIDS AND AWARDS COMMITTEE (BAC) INCORPORATED IN BAC RESOLUTION NO. 2021-097 DATED JULY 23, 2021 ON THE OPENING OF BIDS WHICH IS 24-HOURS AFTER THE DEADLINE OF SUBMISSION OF BID

WHEREAS, BAC Resolution No. 2020-025 dated May 27, 2020 states that the opening of bids shall be done 48-hours after the deadline of submission of bid as recommended by Dr. Alvin A. Isidoro, Municipal Health Officer considering the survival period of the Corona Virus (COVID-19) on surfaces specially in papers or documents;

WHEREAS, for faster implementation of projects, it was agreed upon by the members of the BAC to shorten the confinement period of documents to 24-hours instead of 48-hours after the deadline of submission bid;

WHEREAS, BAC Resolution No. 2021-097 dated July 23, 2021 amended the provision of BAC Resolution No. 2020-025 dated May 27, 2020 on the opening of bids to be changed to 24 hours after the deadline of submission of bid;

WHEREAS, the Municipality has a controlled and very low confirmed cases of COVID-19 for the past months attributed to the fast vaccination scheme adopted by the LGU through the Municipal Health Office (MHO);


WHEREAS, the Province of Laguna remains to be under Alert Level 1 which is the lowest among the five alert levels that estimate COVID-19 risk levels in an area;

WHEREAS, Dr. Alvin A. Isidoro reiterate the use of disinfecting spray and alcohol to ensure that the documents are safe and properly sanitized;

NOW, THEREFORE, We, the Member of the Bids and Awards Committee, hereby RESOLVE as it is hereby RESOLVED;

1. To suspend the internal rule of BAC as per Resolution No. 2021-097 dated July 23, 2021 on the opening of bids 24-hours after the deadline of submission of bid; and
2. To set the opening of bids on the scheduled closing of bid opportunity on PhilGeps; and
