



RESOLUTION NO. 2021-078

RESOLUTION DECLARING THE POST-DISQUALIFICATION OF ISOURCE ASIA BUSINESS SOLUTIONS CORPORATION (LOWEST BIDDER) AND RAND COMPUTER CENTER (SECOND LOWEST BIDDER) AND FAILURE OF BIDDING FOR THE SUPPLY AND DELIVERY OF COPIER MACHINES FOR VARIOUS OFFICES, LOS BAÑOS, LAGUNA

WHEREAS, ISource Asia Business Solutions Corporation was declared as the Lowest Bidder on August 26, 2022 for the Supply and Delivery of Copier Machines for Various Offices, Los Baños, Laguna with the bid amount Two Hundred Fifteen Thousand Pesos and 00/100 (P 215,000.00);

WHEREAS, on September 23, 2022, after careful evaluation and validation, ISource Asia Business Solutions Corporation was declared post-disqualified for non-conformance with the technical specifications contrary to Section 34.3 of the IRR of R.A. 9184 and NPM 024-2018 of the GPPB;

WHEREAS, NPM 024-2018 provides that, "Disqualification during the Post-Qualification stage is covered by Section 34 of the same IRR, where Bids and Awards Committee (BAC) verifies, validates and ascertains all statements made and the documents submitted by the bidder with the Lowest Calculated Bid (LCB) or Highest rated bid (HRB), as the case may be, using non-discretionary pass/fail criteria. The verification under the post-qualification stage is not limited to the examination of documents submitted by the bidder, but also includes inspection of the subject equipment vis-à-vis the technical specifications specified in the bidding documents";


WHEREAS, Rand Computer Center, the Second Lowest Bidder with the bid amount of Two Hundred Seventy-Six Thousand Pesos and 00/100 (P 276,000.00) was also post-disqualified for the same reason of non-conformance with the technical specifications contrary to Section 34.3 of the same IRR and NPM 024-2018 of the GPPB;


WHEREAS, Section 35.1(c) of the Revised IRR of R.A. 9184 provides that the Bids and Awards Committee shall declare the bidding a failure when all bids fail to comply with all the bid requirement or fail post-qualification;


THEREFORE, for and in consideration of the foregoing, we, members of the Bids and Awards Committee, hereby **RESOLVE AS IT IS HEREBY RESOLVED**,


- a) To declare the lowest bidder, **ISOURCE ASIA BUSINESS SOLUTIONS CORPORATION** and second lowest bidder **RAND COMPUTER CENTER** post-disqualified; and
- b) To declare failure of bidding for the Supply and Delivery of Copier Machines for Various Offices, Los Baños, Laguna.
