WHEREAS, a Pre-Bid Conference was conducted last January 14, 2022 which was attended by three (3) prospective bidders via Zoom;

WHEREAS, in response to the said advertisement, three (3) prospective bidders purchased bid documents;

WHEREAS, on January 27, 2022 at the Municipal Hall, Los Baños, Laguna, said bidders submitted and dropped envelopes in the bid box;

WHEREAS, in the opening of bids held last January 28, 2022, the bid proposals of said bidders/suppliers were found to be substantially complying:
