



BAC Resolution Declaring S/LCRB and Recommending Award

RESOLUTION NO. 2022-120

RESOLUTION RECOMMENDING THE AWARD FOR THE ALTERNATIVE METHOD OF PROCUREMENT THROUGH NEGOTIATED PROCUREMENT PARTICULARLY TWO-FAILED BIDDINGS FOR THE SUPPLY AND DELIVERY OF JANITORIAL SUPPLIES FOR VARIOUS OFFICES, LOS BAÑOS, LAGUNA.

WHEREAS, the Supply and Delivery of Janitorial Supplies for Various Offices was scheduled for two consecutive biddings on August 26, 2022 and September 14, 2022;

WHEREAS, no suppliers bought bidding documents and participated on the said biddings, thus resulting to failure of biddings;

WHEREAS, Section 53 of Republic Act No. 9184 known as the Government Procurement Reform Act, stated that "A negotiated procurement can be allowed when there has been failure of competitive bidding or Limited Source Bidding for the second time as provided in Section 35 of the Act and its IRR";

WHEREAS, the BAC, thru its Secretariat has undertaken the following activities:

1. Posted Request for Proposal at the Philippine Government Electronic Procurement System (PhilGEPS) and on the bulletin board of the Municipality on October 29, 2022 and set the deadline of submission of bids on November 3, 2022;
2. Requested quotations from five (5) suppliers of known qualifications, namely:
 - a. AA-3S General Merchandise of Sta. Cruz, Laguna;
 - b. Rand Charlie Enterprises of Los Baños, Laguna;
 - c. Mendo Enterprises of Quezon City;
 - d. SMS Marketing of Los Baños, Laguna; and
 - e. Silver Pulp Trading of Los Baños, Laguna
3. The BAC received one (1) price quotation on November 3, 2022, as follows:
 - a. **SMS Marketing of Los Baños, Laguna amounting to Two Hundred Ninety-One Thousand Four Hundred Twenty-Seven Pesos and 50/100 (P 291,427.50)**


WHEREAS, upon careful examination, validation and verification of all the eligibility, technical and financial requirements submitted to the BAC by the Bidder with the Single Calculated Bid, its bid has been found to be responsive;

WHEREAS, after careful deliberation and study, the Bids and Awards Committee recommended a negotiated procurement particularly Two-Failed Biddings for the **SUPPLY AND DELIVERY OF JANITORIAL SUPPLIES FOR VARIOUS OFFICES, LOS BAÑOS, LAGUNA** to **SMS MARKETING** of **LOS BAÑOS, LAGUNA** in the calculated amount of **TWO HUNDRED NINETY-ONE THOUSAND FOUR HUNDRED TWENTY-SEVEN PESOS AND 50/100 (P 291,427.50)**;


NOW, THEREFORE, We, the Members of the Bids and Awards Committee, hereby **RESOLVE** as it is hereby **RESOLVED**;


