



BAC Resolution Declaring S/LCRB and Recommending Award

WHEREAS, the Municipality of Los Baños advertised the Invitation to Apply for Eligibility and to Bid for the project, **SUPPLY AND DELIVERY OF FRANCHISE PLATE FOR TRICYCLE/PEDICAB, LOS BAÑOS, LAGUNA** on October 20, 2022 and posted the same to PhilGEPS website and the conspicuous place at the premises of the Municipality of Los Baños continuously for seven (7) days;






NOW, THEREFORE, We, the Members of the Bids and Awards Committee, hereby **RESOLVE** as it is hereby **RESOLVED**;
